

1325, 358 DeMolay, La Marque, TX, to Texas City Lodge No. 1118, 702 14th Street North, Texas City, TX,

And WHEREAS, the membership of San Felipe de Austin Chapter No. 1, RAM was notified that this motion would be voted on at the stated meeting on July 16, 2020,

And WHEREAS, at the stated meeting of San Felipe de Austin Chapter No. 1, RAM on September 16, 2020 the motion was made and approved by a majority vote,

And WHEREAS, Most Excellent Grand High Priest David M. Baskin on February 12, 2020, granted dispensation to San Felipe de Austin Chapter No. 1, RAM to assemble for labor at 702 14th Street North, Texas City, TX, until the 2020 Annual Convocation of the Grand Royal Arch Chapter of Texas, and dispensation was re-issued by Most Excellent Grand High Priest Mark D. Myer on February 27, 2021 until the 2021 Annual Convocation.

THEREFORE, BE IT RESOLVED that the Grand Royal Arch Chapter of Texas grants permission to San Felipe de Austin Chapter No. 1, RAM to make permanent the move to Texas City Lodge No.1118, 702 14th Street North, Texas City, Texas.

RESOLUTION NO. 4

Referred to the Committee on Purposes and Policies

To the Most Excellent Grand Royal Arch Chapter of Texas:

WHEREAS Article B-076 of the Constitution and Laws of the Grand Royal Arch Chapter of Texas establishes a Committee on Investments with the requirement to "prepare for presentation to each joint session with the Grand Chapter Trustees, as herein required, its recommendation as to how monies in the General Fund, Endowed Membership Fund, and in all funds of this Grand Chapter shall be prudently invested for the maximum benefit of this Grand Chapter; consistent with those objectives established by the Grand Trustees"; and

WHEREAS Article B-076 further states "The Committee on Investments and the Grand Chapter Trustees shall meet each calendar quarter in joint session, exchange information pertinent to the investments of this Grand Royal Arch Chapter on a quarterly basis, to consider the recommendations of the Committee on Investments as to the appropriate investment of monies in the General Fund, Endowed Member Fund, and in each special fund of this Grand Royal Arch Chapter"; and

WHEREAS Article B-076 implies but does not explicitly state a requirement that the Committee on Investments and the Grand Chapter Trustees write and formally adopt an Investment Policy;

THEREFORE, BE IT RESOLVED that Article B-076 of the Constitution and Laws of the Grand Royal Arch Chapter of Texas be amended to read:

Art. B-076 (72-A) Committee on Investments. In addition to those Permanent Committees listed in B070, the Committee on Investments herein referenced shall be a Permanent Committee of this Grand Chapter; it shall satisfy all criteria set forth in these Laws except each member may succeed himself after serving a full five year term. Each member shall have the qualification set forth herein. (Adopted 1997)

The Committee on Investments shall consist of five Royal Arch Masons; each of whom shall be a member and a Past High Priest in this Grand Jurisdiction; however, if such is not available, then the Committee may include no more than three Royal Arch Masons who are otherwise qualified to serve, and who are members in good standing of a Royal Arch Chapter in this Grand Jurisdiction. The Chairman shall at all times be a member of this Grand Chapter. (Adopted 1997)

Each member of the committee shall be experienced in financial investments as a result of substantial time (not less than five years) spent as a professional in the field of financial management and investments. (Adopted 1997)

The Committee shall prepare for presentation to each joint session with the Grand Chapter Trustees, as herein required; its recommendation as to how monies in the

General Fund, Endowed Membership Fund, and in all funds of this Grand Chapter shall be prudently invested for the maximum benefit to this Grand Chapter; consistent with those objectives established by the Grand Trustees. (Adopted 1997)

The Committee on Investments and the Grand Chapter Trustees shall meet each calendar quarter in joint session, exchange information pertinent to the investments of this Grand Royal Arch Chapter on a quarterly basis, to consider the recommendations of the Committee on Investments as to the appropriate investment of the monies in the General Fund, Endowed Membership Fund, and in each special fund of this Grand Royal Arch Chapter. (Adopted 1997)

The Committee on Investments and the Grand Chapter Trustees shall annually jointly prepare and adopt a formal Investment Policy for the investment and disbursement of the funds in the General Fund, Endowed Membership Fund, and in each special fund of this Grand Royal Arch Chapter. The Investment Policy shall address both the prudent investment of funds and the manner and amount of any disbursement of funds, including retainage of a portion of earned income to become a part of the principle of each fund. In making such decisions, Committee members and Trustees shall consider such economic factors as inflation, Consumer Price Index (CPI), Federal Reserve interest rates, and other economic factors, indicators and trends. The Investment Policy shall include a percentage of earned income to be retained and added to the principle. The Investment Policy shall be included in the Report of the Committee on Investments and be published in the annual Proceedings of the Grand Royal Arch Chapter of Texas. (2021)

Investment policies and procedures shall require a combined majority approval of the Trustees and members of the Committee. (Adopted 1997)

The Committee shall make its annual report to this Grand Chapter at each of its Annual Convocations. (Adopted 1997)

RESOLUTION NO. 6

Referred to the Committees on Jurisprudence*, Purposes & Policies

To the Most Illustrious Grand Council of Royal and Select Masters of Texas:

WHEREAS Article B-071 of the Constitution and Laws of the Grand Council of Royal and

Select Masters of Texas establishes a Committee on Investments with the requirement to "prepare for presentation to each joint session with the Grand Council Trustees, as herein required, its recommendation as to how monies in the General Fund, Endowed Membership Fund, and in all funds of this Grand Council shall be prudently invested for the maximum benefit to this Grand Council; consistent with those objectives established by the Grand Trustees"; and

WHEREAS Article B-071 further states "The Committee on Investments and the Grand Council Trustees shall meet each calendar quarter in joint session, exchange information pertinent to the investments of this Grand Council on a quarterly basis, to consider the recommendations of the Committee on Investments as to the appropriate investment of the monies in the General Fund, Endowed Membership Fund, and in each special fund of this Grand Council of Royal and Select Masters of Texas"; and

WHEREAS Article B-071 implies but does not explicitly state a requirement that the Committee on Investments and the Grand Council Trustees write and formally adopt an Investment Policy;

THEREFORE, BE IT RESOLVED that Article B-071 of the Constitution and Laws of the Grand Council of Royal and Select Masters of Texas be amended to read:

Art. B-071 (67). Committee on Investments. In addition to those Permanent Committees listed in Article No. B-063 (61), the Committee on Investments herein referenced shall be a Permanent Committee of this Grand Council; it shall satisfy all criteria set forth in these Laws except each member may succeed himself after serving a full five year term. Each member shall have the qualification set forth herein. (Amended 1997)

The Committee on Investments shall consist of five Royal and Select Masters; each of whom shall be a member and a Past Thrice Illustrious Master in this Grand Jurisdiction; however, if such is not available, then the Committee may include no more than three Royal and Select Masters who are otherwise qualified to serve, and who are members in good standing in a Council of Royal and Select Masters in this Grand Jurisdiction. The Chairman shall at all times be a member of this Grand Council. (Adopted 1997)

Each member of the Committee shall be experienced in financial investments as a result of substantial time (not less than five years) spent as a professional in the field of financial management and investments. (Adopted 1997)

The Committee shall prepare for presentation to each joint session with the Grand Council Trustees, as herein required; its recommendation as to how monies in the General Fund, Endowed Membership Fund, and in all funds of this Grand Council shall be prudently invested for the maximum benefit to this Grand Council; consistent with those objectives established by the Grand Trustees. (Adopted 1997)

The Committee on Investments and the Grand Council Trustees shall annually jointly prepare and adopt a formal Investment Policy for the investment and disbursement of the funds in the General Fund, Endowed Membership Fund, and in each special fund of this Grand Council. The Investment Policy shall address both the prudent investment of funds and the manner and amount of any disbursement of funds, including retainage of a portion of earned income to become a part of the principle of each fund. In making such decisions, Committee members and Trustees shall consider such economic factors as inflation, Consumer Price Index (CPI), Federal Reserve interest rates, and other economic factors, indicators and trends. The Investment Policy shall include a percentage of earned income to be retained and added to the principle. The Investment Policy shall be included in the Report of the Committee on Investments and be published in the annual Proceedings of the Grand Council of Royal and Select Masters of Texas. (2021)

The Committee on Investments and the Grand Council Trustees shall meet each calendar quarter in joint session, exchange information pertinent to the investments of this Grand Council on a quarterly basis, to consider the recommendations of the Committee on Investments as to the appropriate investment of the monies in the General Fund, Endowed Membership Fund, and in each special fund of this Grand Council of Royal and Select Masters of Texas. (Adopted 1997)

Investment policies and procedures shall require a combined majority approval of the Trustees and members of the Committee. (Adopted 1997)

The Committee shall make its annual report to this Grand Council at each of its Annual Assemblies. (Adopted 1997 & Amended 1998)
